- III. Correspondence Manchester Housing Authority Year 1 Siemens M&V Report Mr. D'Ascoli shared he will be meeting with Siemens on January 29. The meeting will discuss the report received from Siemens regarding the energy savings that MHA as received. Initially the savings should have been \$176,710 but this report indicates a 9% savings over that of \$192,882. Mr. D'Ascoli said he has discussed this with our Consultant Nathan Bonder and he will look this over to be sure the numbers are correct.

- 2. Update to Westhill Congregate Revitalization Mr. D'Ascoli reported on the status of the Congregate. The contractor has not shown up since mid-December and they have been paid in full as of their last invoice. Some of the items that have not been completed are the curtain walls by the loading dock need to be done. The Exterior still needs the paving of the parking lot, landscaping, flag & light poles and the canopy. The contractor states the canopy cannot be installed unless the temperature is 50 degrees or more. When MHA asks what the final costs are we get no response. Next meeting has been rescheduled to January 22.
