**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Through the RAD, Section 18 and Streamlined Voluntary Conversion programs, the Housing Authority of the Town of Manchester intends to convert the public housing units located at Mayfair Gardens, Westhill Gardens, Westhill Gardens Annex (Phase II) and Scattered Sites to Project Base Vouchers (PBV). The development also includes one non-dwelling structure that will be included in the conversion.

This conversion includes a total of 317 units of which 42 units are currently designated as General Occupancy and 275 units are designated as Elderly and will remain designated as such after conversion. The bedroom distribution of these units is listed in the table below and will remain as such following conversion to PBV. The units involved are in need of minimal repairs and will be rehabilitated as a part of the conversion.

Below is HATM’s Conversion of Public Housing to Project-Based Assistance under RAD, Section 18 and Streamlined Voluntary Conversion.

After conversion, HATM does not intend to change any policies that govern eligibility, admission, selection, and occupancy of the units.
